



Theft insurance

In the General Terms and Conditions you will find definitions of the terms that appear in various sets of conditions. These definitions apply to the General Terms and Conditions, the insurance conditions, the clauses and the provisions on the policy schedule.

Article 1. Scope of the cover

We indemnify damage occasioned by theft or defalcation of the insured horse.

Article 2. Compensation

We indemnify 100% of the insured amount.

Article 3. Additional exclusions

We do not indemnify any damage:

- a. brought about by the horse going missing;
- b. if the horse can be recovered within 30 days of the occurrence having been reported.

Article 4. Additional claims procedure

We are only obliged to pay compensation:

- after a period of 30 days after we have received the report of the occurrence, and;
- after you have transferred the rights of ownership of the horse to us by means of a written waiver and;
- once you have forwarded all official identification papers to us.
